The Minutes of the January 29, 1980 Ratepayers Meeting were distributed.

MOTION: Moved by Michelle Ashdown, seconded by John Hollins that the minutes be adopted. CARRIED.

Mike Roche gave a brief outline on the proposal for distribution of the proposed 1981 Recreation Grant.

MOTION: Moved by Don Gray, Seconded by John Pollard that the distribution of the Recreation Grant be approved.

Art Szabo questioned why Competitive Softball was receiving a grant when we did not support other competitive teams. Nelson Williams (Sports Director for BCA) replied that they had planned for a second team, however, after much discussion the following motion was made.

AMENDMENT: Moved by John Hollins, seconded by Lois Kemp to remove the expenditure for competitive softball. WITHDRAWN.

AMENDMENT: Moved by Lois Kemp, seconded by John Hollins to reduce the amount of grant for competitive softball from \$770. to \$140. CARRIED.

The Grant for the new Karate program was presented in detail by John Pollard and Mike Roche as a result of a question put forward by Lois Kemp.

AMENDMENT: Moved by John Hollins, seconded by Terry Dawson to increase the Grant for Scouts to \$1000. in total and the word Guide be deleted. (This was requested because 1981 is the year of the Scout Jamboree and extra expenditures will be incurred.) CARRIED.

In response to a question by Jo-Anne Cottingham with regards to the BCA Guide Grant, John Pollard advised they had requested and would be receiving \$125.

GENERAL MEETING

President Mike Roche call the General Meeting to order.

MOTION: Moved by John Pollard, seconded by Jo-Anne Cottingham that the Minutes of the BCA General Meeting, held on May 29, 1980 be adopted as printed in the April 1980 Banar. CARRIED.

1981 BLACKBURN COMMUNITY ASSOCIATION BUDGET

After discussion from the floor regarding the deficit budget, increasing costs for ice time, space rentals and equipment and an explanation of the canteen status the above MOTION was CARRIED UNANIMOUSLY.

President Mike Roche gave an updated report on the status of the BY-PASS and explained that there will be a public meeting before Regional Council makes a decision.

OTHER BUSINESS

Dave Wardlaw raised a concern about the condition of ball diamonds. It was agreed that Mike Roche, Dave Wardlaw, Nelson Williams and Eldon Kemp would look into the problem and develop a solution.

Banar policy regarding advertising submissions was questioned by Lois Kemp with regard to her Gateway to Gloucester Project. Gwen Pollard explained that Gloucester Area fund raising inserts are billed at cost. Only organizations sponsored by BCA may have ads printed free of charge and these must be submitted by the BCA sponsored group. Mrs. Kemp was invited to deal directly with the Executive of the BMHA.

George Bushell raised the question of expenditures of Fun Fair reserves and suggested that a general authority should be on record to cover expenditures from these reserves.

MOTION: Moved by John Hollins, seconded by George Bushell that a supplementary Budget be approved for \$15,000. to cover expenditures from Fun Fair reserves in accordance with recommendations of the Fun Fair Board of Directors and subject to the approval of the BCA Board of Directors, in each case. CARRIED.

MOTION: Moved by Terry Dawson, seconded by Carol Baker that the meeting be adjourned at 10:15 p.m. CARRIED.
